Denise and Tony are steadfast in their dedication and service to the Center and are truly worthy recipients of the Carolyn Fish Human Rights Award.

CONNECTING THE DOTS

Center for Safety & Change provides services not only to victims and survivors of domestic violence, sexual assault, human trafficking and all crimes, but their friends and family members as well. Several times a year, the Center offers "Connecting the Dots," an educational support group, presented in both English and Spanish, for parents, partners and adult siblings of children who have been sexually abused. The Center also offers individual counseling for friends and family of victims and survivors of all crimes, like Janice. When Janice learned that her teenage daughter was sexually abused by a family friend, she felt completely overwhelmed. Her first concern was her daughter's safety and emotional wellbeing. Janice's daughter received services and support from Center for Safety & Change, including counseling and advocacy. Janice also began working with a counselor at the Center. In her own words:

"When I reluctantly began therapy several years ago, I thought that it would be a waste of time. No one could possibly understand or help me lose the pain I felt as my teenage daughter was molested by my friend. The hurt was enormous and the pain immeasurable. My anger extended to my daughter and myself. After months of working with a Center for Safety & Change counselor, I realized that the goal of this experience wasn't to eliminate my pain, instead it was to work through it while keeping my family together. It was equally important to learn to trust again, to trust myself, my daughter and others. This is coming gradually. I want to express my most sincere appreciation to my counselor and to the Center for the kindness and help which enables me to manage doubt and anger."

PROGRAM HIGHLIGHTS: LEGAL PROGRAM



The Center for Safety & Change Legal Department has grown tremendously since it was launched as the Mary Weingard Domestic Violence Law Project in 1994. The Center's Legal Department provides free and confidential services to victims and survivors of domestic/dating violence, sexual assault, human trafficking and stalking, including advocacy, accompaniment and representation in Family Court, Civil Court and Federal Immigration Court. In the fall of 2017, Center for Safety & Change, along with our partners Big Brothers Big Sisters of Rockland County, Legal Aid Society of Rockland County and VCS Inc., were awarded two three-year grants. Totaling over \$1.1 million, the grants allow us to expand legal and advocacy services to Spanish-speaking and immigrant victims and survivors of domestic violence, sexual assault, and human trafficking in Rockland County.

Andrea Panjwani was appointed Center for Safety & Change Director of Legal Services in November 2017. When asked about her vision for the Legal Department, Andrea said:

"I am excited to have joined the Center's legal program during this time of growth and to have the opportunity to parlay my experience representing survivors and immigrants in Miami and New York City to Rockland County, my home of thirteen years. Sena Kim-Reuter, our managing attorney, Stefany Ovalles, our staff attorney, and Amy Kellogg, our legal fellow, have recently joined our legal team and bring a wealth of experience and talent. In addition, we are blessed to have on staff Dilcia Suarez, our BIA-accredited representative, Arlene Gordon, our paralegal, Colleen Farrell, our domestic violence court advocate, and Nancy Donoghue, Jenny Guzman and Vanessa Cardoso, our legal advocates.

It is our privilege to serve survivors of all ages, genders, races, ethnicities, religions, nationalities, incomes and physical/mental health statuses in a way that meets them where they are, honors their stories and zealously supports their legal goals. In response to some of the gaps that exist in Rockland County, we have expanded

our legal services and now provide immigration and human trafficking-related representation to help non-citizen survivors stabilize their lives and minimize re-victimization. Fear of deportation/ family separation and the inability to earn a living wage are two of the factors that keep non-citizen survivors in exploitive situations obtaining legal status is essential to breaking the cycle of abuse. As part of the human trafficking work, we help survivors who have been labor trafficked or exploited redress wage theft and play a victim rights advocate role throughout the criminal justice process when relevant. We continue to represent survivors in family court proceedings and have expanded our family law outreach and intake services. One of the things I most appreciate about Rockland County is the way people meet around the table across sectors - law enforcement, non-profit, legal, judicial, private and faith - in an effort to better serve the survivor community. Our legal team is very much committed to building capacity to serve survivors and looks forward to deepening collaborations."
