### What does a trafficker look like?

A trafficker/pimp can be anyone, male or female. They may even be someone you know, trust and look up to.

#### **Recruitment tactics include:**

- Violence
- Force
- Promise of Wealth
- False Love/Acceptance
- False "Family"

- Threats
- Lies
- Possession of Documents
- Control and Manipulation

Who are the victims of child/teen trafficking?

# Anyone can be trafficked.

#### Some higher-risk populations include:

- Youth with a History of Abuse, Neglect or Substance Use
- Youth with Impairments
- Refugee, Immigrants and Non-English-Speaking Youth STATISTICS OF ST
- Youth in Foster Care
- Homeless or Runaway Youth
- I GBTQ+ Youth



## **Traffickers use to target Youth:**

Transportation Areas, Sporting Events, Casinos, Tourist Attractions, Hotels, Parties, Malls, Concert Venues and More

## What is the Safe Harbor Law?

Anyone under 18 years old is protected under Safe Harbor from being charged as a criminal.

#### Minors are victims of CSEC under federal law for the following:

- Prostitution Pornography
- Trading Sexual Acts for Food,
- **Clothing or Shelter**
- Stripping
